

ROSS TOWNSHIP SUPERVISORS
MONTHLY MEETING
JULY 6, 2015

The Regular Monthly meeting of the Ross Township Supervisors was called to order by Chairman Beers with members Vice Chairman Drake and Supervisor Kresge present. The meeting began at 7:00 p .m. with the Pledge of Allegiance to the Flag. Solicitor Dunn was absent.

A motion was made by Vice Chairman Drake to approve the minutes of the June 1, 2015 meeting and the Treasurer's report as presented. The motion was seconded by Supervisor Kresge and carried.

The following bids were opened and read in response to the Township's request for bids on road materials and paving:

Hanson Aggregates Pa. LLC for 300 tons more or less of AAshto #3-\$10.00 per ton, 2a stone \$7.25 per ton, AAshto #1-\$10.00 per ton, AAshto #57-\$13.35 per ton, #8 stone-\$14.00 per ton, 2RC-\$6.00 per ton, Cold patch-\$95.75 per ton, Gabion-\$15.25 per ton, 3A modified-\$8.00 per ton.

Bruce George Paving & Excavating, Inc. -Mountain Woods Rd. scratch leveling, Mountain Woods Rd. wearing, Spruce Rd., Owl Hollow Rd., Pine Cone Ct. including line striping \$289,175.16.

Hanson Aggregates Pa. LLC-Mountain Woods Rd. scratch leveling, Mountain Woods Rd. wearing, Spruce Rd., Owl Hollow Rd., Pine Cone Ct. including line striping \$293,107.04.

Chairman Beers moved to award the bids to Shiffer Bituminous Service Co. for oil, Hanson Aggregates for materials and Bruce George Paving and Excavating, Inc for paving work. The motion was seconded by Vice Chairman Drake and carried.
