## **#2012-1 NOLF MINOR SUBDIVISION**

Engineer, Terry Martin was present to discuss the plan. A 2 acre parcel is being subdivided from existing lands on Stone Hill Lane. The comments were reviewed from the letter dated February 10, 2012 from Russ Kresge & Assoc. Comment 1) the applicant request that a letter be sent to assessor's office stating that: the gross acre is 2.02, the definition says 2.00 net exclusive of the road and future road widening, the assessor's office says no more than 2.00 acre. Comment 2) Recreation fee is required. Comment 3) Stormwater management, is covered by Covenant # 15. Comment 4A) sight distance requirement, after some discussion it was determined that the sight distance has been met. 4B) the Road Forman has issued a driveway permit. 4C) is a request for a waiver as the driveway exceeds the grade permitted, Barry Shoemaker made a motion to recommend the waiver be granted, and Ron Boyd seconded the motion. Motion carried. 4D) the position of the driveway may have to be moved so the apron is not in front of the adjacent driveway, this has already been amended. 4E) the stormwater runoff will be evaluated by the Road Foreman. The letter dated January 25, 2012 from Monroe County Planning Commission was reviewed. Ron Boyd made a motion to recommend the plan for approval. Barry Shoemaker seconded the motion. Motion carried.
