## Ross Township Van Buskirk-Haney Park

### Park and Pavilion Rules and Regulations

1. Picnic tables or other park items are not to be removed from pavilion and all displays and decorations must be removed.
2. Groups who have reserved the upper pavilion have priority over daily users.
3. Use of the lower pavilion will be on a first come first serve basis.
4. All activities/events involving more than 10 persons must have appropriate approvals.
5. Users must supply all sports equipment.
6. This park is specifically designed for passive activity.
7. Fishing is "catch & release" only. No camping. No swimming.
8. Clean up after you are done & take all trash with you. Leave the park clean and orderly.
9. Open fires are prohibited. Use of gas grills is permitted in picnic areas.
10. Dogs are permitted on walking trails and grassy areas. **DOGS MUST BE LEASHED AND PROPER WASTE DISPOSAL PROCEDURES FOLLOWED AT ALL TIMES.** No horses.
11. **THIS PARK IS A DRUG FREE ZONE. SMOKING AND THE USE OF ALCOHOLIC BEVERAGES ARE NOT PERMITTED.**
12. Unauthorized vehicles are restricted to parking areas only.
13. No motorized vehicles or remote-controlled devices.
14. Soliciting, posting of signs, distribution of products or equipment is prohibited.
15. Hunting, weapons, firearms, air guns or explosive devices are prohibited.
16. Damaging, defacing, removing or attempting to remove any manmade or natural object is prohibited.
17. Disturbance of the peace by any conduct (e.g. loud/offensive music, profanity, aggressive behavior) so as to cause a nuisance to others or wildlife is prohibited.
18. The Township has the right to enforce these rules. Anyone not following these rules will NOT be permitted to use the park in the future.
