Intention to Enact Ordinance Intergovernmental Cooperation Agreement to Dissolve the WEPOSC A motion was made by Supervisor Detrick to adopt Ordinance #93 authorizing an intergovernmental cooperation agreement to dissolve the West End Parks and Open Space Commission , seconded by Chairman Zahoroiko and carried.

ROAD FOREMAN REPORT:

The report completed by Road Foreman Ethan Brewer was reviewed by the Board of Supervisors. Ethan discussed pricing for Culvert material pending rate. Vice Chairman Shay made a motion to set salary for part time non CDL position for part time snow removal at \$15.00 per hour, the NON CDL rate. The motion was seconded by Supervisor Randy Detrick and carried.
