2024 Road Project -The sealed bids received from James D Morrissey, Inc., Bracalente Construction, Inc., H & K and Bruce George Paving & Excavation, Inc., for Paving Project and Asphalt Maintenance Solutions, LLC for Seal Coat Project were opened and announced by Vice Chairman Shay in response to the advertised 2024 Ross Township Road Project.

James D. Morrissey, Inc. Road prices \$97.00 per ton -118.00 per ton total bid \$331,447.00, Bracalente prices range from \$117.53 -\$125.33 per ton, total bid \$383,265.56,H & K Group, Inc. prices range from \$113.00-\$155.00 per ton, total bid \$387,676.00 and Bruce George Paving and Excavating, Inc. prices range from \$111.17- 128.01 total bid \$367,742.92.

After a review of the bids and discussion, a motion was made by Vice Chairman Shay to award the bid to James D Morrissey for Paving, Alternate Bid Stone Hill Lane and Evergreen Court in the amount of

\$186,168.00. The motion included awarding the Seal Coat bid to Asphalt Maintenance Solutions, LLC, in the amount of \$51,084.08 to tar and chip Anchorage Road Section 1 and 2. The amount of Paving and Seal Coat projects approved is \$237,252.08. 2024 Liquid Fuels in the amount \$249,443.71. The motion was seconded by Supervisor Detrick and carried.

### **ROAD FOREMAN REPORT:**

Road master was unable to attend meeting, however submitted a written report to the Supervisors and also contacted them by phone in regards to road project. A suggestion to hold a pick up Ross Township Road was made by Road Master and details will be posted on Facebook and Website.

High bid received for 2001 Truck in the amount of \$11,500.00.

#### **ZONNG DEPARTMENT UPDATE:**

Meixsell Valley & 115 signs cleaned up. Collins Ave is cleaned up and distressed properties have been cleaning up. Camper has been removed from Meixsell Valley Road. Barn on Meixsell Valley also taken down. Discussion about ordinance revision or addition needs to be continued and added to next meeting agenda. Vice Chairman Shay and Supervisor Detrick are going to create a flow chart of progress related to zoning complaints and communication moving forward.
